1.1 Vision and Mission of the Educational Institution:

First: The vision and mission of Assiut University

1) Vision

Leadership in building a knowledgeable society.

2) Mission

Assiut University is a public university that mobilizes and utilizes its energy towards achieving its vision by providing education that meets the requirements of the present and the future. It aims to generate distinguished generations of graduates capable of competing in local and global labor markets and excelling in the fields of scientific research and technology. Within the context of university values, the university also attempts to design and conduct research programs that promote knowledge and contribute to societal development.

Second: The vision and mission of the community service and environmental development sector at Assiut University

1) Vision

Environmental development and community service through the university in all fields.

2) Mission

Assiut University was established under the slogan “University without Barriers”. Its notable contributions extend to community service and environmental development due to its human cadres with distinguished scientific competence. It also has laboratory and research capabilities that provide environmental services and consultations. Besides, it supports the process of sustainable development through several axes as follows:

- Study and propose public policies, plans, and programs to achieve the university's mission regarding community service and environmental development,
- Holding conferences, scientific and cultural seminars, workshops and related training programs,
- Directing applied scientific research to solve environmental problems in various scientific sectors.
- Organizing integrated environmental convoys in the fields of public service.
- Follow-up of environmental legislation and agreements issued at the local, regional, and international levels.

Third: The vision and mission of some faculties of Assiut University as models (compatible with the vision and mission of the university). It will be presented according to the seniority of the faculties.

1. Faculty of Science

- **Vision**

The Faculty of Science at Assiut University aspires to occupy a prominent scientific position among the Egyptian and regional faculties of science. It seeks to provide society with exceptional graduates capable of creativity and innovation in the fields of community service, industry, education, and scientific research, as well as competing locally and internationally.

- **Mission**

The Faculty of Science at Assiut University is an institution of higher education and scientific research in the field of basic sciences. It seeks to achieve the mission of the university by following moral and religious traditions and values. This is done through:

- Preparing generations of scientists and workers in scientific, research, educational, and industrial centers,
- Providing students with the best educational services in the field of basic sciences at the bachelor's level, as well as providing them with the skills required in the specialization through educational programs that adhere to national standards,
- Contributing to the advancement of mathematics, computer science, physical, chemical, biological, and geological sciences through postgraduate programs and research,
- Employing the university's human resources, research capabilities, and consulting expertise to contribute to solving environmental problems, serving the manufacturing and service sectors, and working to improve society,
- Preserving the uniqueness of the faculty in studying the development of the South Valley and implementing projects that support the policy of exiting the narrow valley in southern Egypt.

2. Faculty of Engineering

- **Vision**

Leadership in building a knowledgeable society in engineering fields.

- **Mission**

The Faculty of Engineering at Assiut University strives to provide exceptional engineering education and scientific research that keeps pace with contemporary developments and is linked to local and regional demands. The faculty also seeks to meet the needs of industrial institutions, service agencies, and national projects by presenting skilled and innovative engineers in various specializations within the framework of university values.

3. Faculty of Agriculture

- **Vision**

Achieving excellence and leadership in agricultural education, scientific research, and community service through a commitment to quality and continuous development in the context of supportive research, cultural, and value environments to achieve sustainable development and meet labor market demands locally and regionally.

- **Mission**

Providing high-quality educational programs that equip skilled graduates to work in a variety of agricultural fields, as well as conducting scientific and applied studies to solve societal problems and develop natural and human resources available in the local environment. This is accomplished through the adoption of the concept of continuous development and the creation of positive values as a technique of performance in the faculty, in accordance with the university's mission.

4. Faculty of Medicine

- **Vision**

Obtaining a leading regional and internationally advanced classification through continuous excellence in education, scientific research, and community service.

- **Mission**

The Faculty of Medicine at Assiut University is dedicated to graduating competent physicians capable of good medical practice, continuing medical education, and competition on a local and regional level. It also commits to contributing to improving scientific research, developing the profession, and providing satisfactory health services to the community within an ethical and moral framework.

5. Faculty of Veterinary Medicine

- **Vision**

The Faculty of Veterinary Medicine at Assiut University strives for excellence in veterinary medical sciences on a local, regional, and global scale. It also strives to improve the educational process and the level of scientific research, as well as to expand it to embrace all areas connected with field difficulties and provide appropriate solutions that contribute to livestock development.

- **Mission**

The mission of the faculty of Veterinary Medicine is to equip competent veterinarians for the labor market by preparing good infrastructure and knowledge for the graduates and equipping them with the technical capabilities needed to compete locally and regionally. In addition, the faculty aspires to direct scientific research in the field of veterinary medicine to serve the community and its needs in various sectors of the veterinary field.

6. Faculty of Education

- **Vision**

To become a regional and global pioneer in the fields of teaching, learning, scientific research, and community services on a local and regional level.

- **Mission**

An accredited institution strives to prepare creative educational teachers capable of keeping up with technological advancements and new trends in teaching and learning now and in the future, as well as excelling in educational research. This is accomplished by updating the faculty's curricula and various sections, as well as establishing and implementing research and training programs that foster knowledge development within the framework of university principles in a way that contributes to the development of society and within the framework of the university's overall value.

7. Faculty of Social Work

- **Vision**

The Faculty of Social Work aspires to prepare graduates with high-quality experience and abilities to keep up with rapid scientific and technological changes. The graduate, additionally, must be able to compete in the local and national labor markets while providing aspects for the educational process's continual development and upgrading. The mission also includes developing graduates' abilities. This is accomplished through intense training courses and workshops, as well as postgraduate (master's and doctorate) programs. By undertaking field research, the faculty enriches the social and human sciences while also supporting the community and developing the environment through technical and professional assistance.

1.2 Governance and administrative systems serve sustainability:

The Environmental Sustainability Committee at Assiut University is formed and approved under the chairmanship of Professor Dr. Vice President for Environmental Affairs and Community Service and the membership of several faculty staff

members, their assistants, and several students, ensuring that they represent the various faculties on campus. The committee is responsible for developing, implementing, and following up on the university's environmental sustainability plan.

Activities and implementation mechanisms

- Develop and carry out an environmental management system (EMS) that meets the international standard ISO 14001 to demonstrate the commitment to continual development of the EMS to improve environmental performance;
- Inventory and documentation of all university activities aimed at achieving environmental sustainability;
- Oversee, promote, and monitor the implementation of the environmental sustainability plan;
- Follow up on the progress of the strategic plan, in addition to submitting periodic reports on its activities regarding environmental achievements at the level of all faculties of the university, areas of improvement, and any related issues;
- Measuring the sustainability performance at the university periodically;
- Provide information on sustainability-related activities at the university.

1.3 The existence of a clear policy and plan for sustainability (green offices - sustainable development)

Assiut University aspires to be an outstanding educational institution focused on sustainable development. To accomplish this goal, Assiut University seeks to achieve an integrated set of strategic objectives that necessitate an effective contribution to sustainable environmental development, whether at the level of directing scientific research to address environmental challenges or disseminating green culture and caring for the human element. This is in addition to the interest in developing and promoting good environmental practices in all aspects of campus life and the community at large.

As a result, and in light of the sustainability plan, a set of guiding policies for the plan and creating the strategy for environmental sustainability at Assiut University have been identified. These policies reflect the university's commitment to decreasing negative environmental consequences while encouraging good environmental impacts. These policies are as follows:

(When developing sustainability policy, several universities, including the United Arab Emirates University, were consulted.)

Participation Policy:

Participation, according to Assiut University, is the most crucial policy for achieving the environmental sustainability strategy. The participation concept is consistent with the university's strategic goals of environmental conservation, social participation, and governance. As a result, Assiut University will be eager to engage in community discussion and will consider the needs of all key stakeholders as it implements and monitors the strategic plan for environmental sustainability. Recognizing their requirements and concerns is the main challenge when making environmental sustainability decisions.

Human Support Policy:

Without a doubt, human resources are the focal point around which sustainable development revolves, based on future generations' rights to development. As a result, one of the key directions of Assiut University's policy in carrying out its plan for sustainable environmental development is to promote human resources. The university's policy supports the continuous success of its progress in its strategic service to environmental sustainability by supporting human resources and striking a balance between the demands of individuals, society, the environment, and the desired results.

Environmental Standards Compliance Policy:

Assiut University is committed to complying with the best practices and environmental standards recognized at the local and worldwide levels. It implements its strategic plan for sustainable environmental development. This ensures long-term benefits for all and mitigates the effects of the university's numerous operational activities. This policy calls for adherence to all environmental regulations, laws, and practices. It also calls for creating environmental goals as part of the implementation of the internal environmental management system and ensuring that these objectives are compatible with local, regional, and global environmental goals.

Governance Policy:

To ensure the accomplishment of the objectives of Assiut University's strategic plan for sustainable environmental development, the university is dedicated to developing clear and defined governance frameworks. This entails regular disclosure of data and information as well as accepting responsibility for the university's activities and the

consequences of those activities. This also includes attempting to build trust with various stakeholders, both internally and externally, through a commitment to transparency and credibility.

Flexibility Policy:

There is no doubt that the rapid environmental changes, which affect many factors, whether at the social, cultural, technological, or other levels, necessitate a flexible policy when pursuing the university's sustainable environmental development strategy. In this regard, it has been considered that the elements of the strategic plan should be sufficiently flexible to face numerous environmental changes and work in accordance with their developments.

For example, the appearance of the coronavirus pandemic has imposed on everyone inside and outside the crisis the necessity to deal with it flexibly, predict its consequences, and not lose sight of the focus on the determined objectives. As a result, flexibility is one of the key policies that guide and direct the work of Assiut University's sustainable environmental development strategy and those in charge of its execution

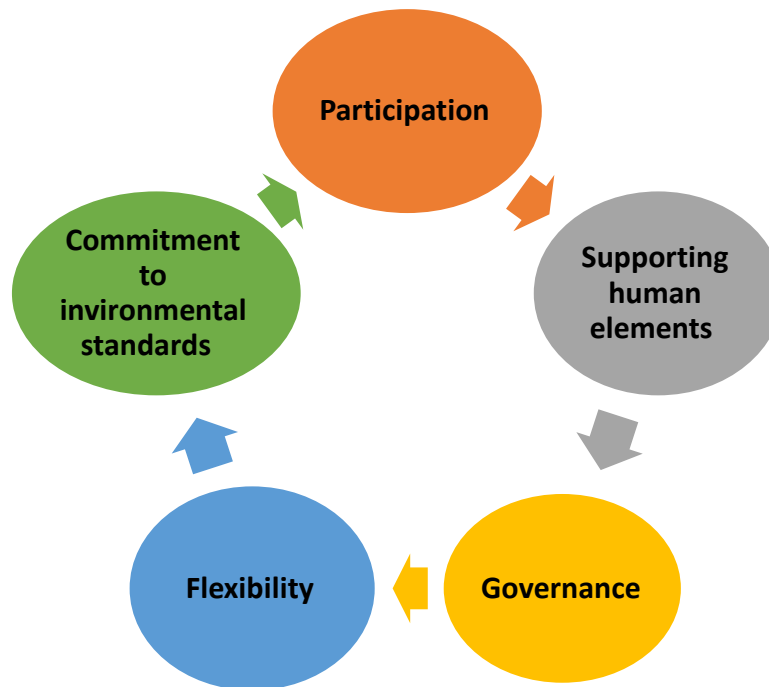


Figure (1) Sustainable Development Policies at Assiut University

Assiut University Policies in the Field of Social Participation (Approved by the University Council Session under No. (689) dated 30-07-2018 extended until 10-08-2018.

Contribute fundamentally to the growth and development of society and lead its change by:

1. Linking the research conducted at the university with the problems and needs of service and production institutions
2. Organizing training and qualification programs to raise the level of employee performance
3. Providing technical advice and allowing some university professors to work as consultants in community institutions
4. Forming scientific awareness among community members through seminars and cultural and therapeutic convoys
5. Participation of public figures in university councils to link the university with the community
6. Holding conferences, seminars, and cultural gatherings
7. Providing technical and scientific consultations to institutions and sectors of society
8. Adopting an environmentally friendly policy for the management of university facilities and the safe disposal of waste and high-risk waste

The Proposed plan to achieve sustainability at Assiut University

The proposed plan to achieve sustainability focuses on the following objectives:

(A group of universities such as the United Arab Emirates University were consulted when making the sustainability plan)

1. Disseminating the culture of environmental sustainability,
2. Governance and administrative system that serves sustainability,
3. Maximizing community participation in environmental sustainability,
4. Maximizing environmental sustainability practices,
5. Maximizing the role of university and postgraduate education in achieving environmental sustainability,
6. The means of communication through which the sustainability policy is disseminated.

The following is an explanation of the objectives of the proposed plan to achieve sustainability:

1. Disseminating the culture of environmental sustainability

This goal focuses on spreading the culture of environmental sustainability both within the campus between students and university staff and outside the surrounding community. By achieving this goal, the culture of the human element is changed and qualified to deal positively with environmental sustainability activities.

Activities and implementation mechanisms:

- Supporting the image of sustainable environmental development to become a major part of the university and its operations
- Creating a culture of rationalization and energy consumption through training, education, and awareness campaigns
- Developing the values, skills, and environmental knowledge of students and university employees
- Maximize the green behavior of the employee

Measurement indicators:

- The number of awareness campaigns
- The number of workshops and training courses
- Performance reports on the green behavior of university employees
- The size of the incentive rewards provided to parties committed to environmental performance, whether inside or outside the university
- Questionnaires

Time Range:

Three years from 2021 to 2024

2. Maximizing community participation in environmental sustainability

To ensure a better future and live in a safe and healthy environment, this goal focuses on activating and maximizing the university's participation in various parts of the surrounding community. This can be done by implementing local activities and events or by disseminating the culture of sustainable environmental development.

Activities and implementation mechanisms

- Supporting innovation and new projects with staff, students, and stakeholders
- Engaging regional partners and businesses to build capacity for sustainable development management
- Activating the role of modern technology to enhance the participation of students and community parties in sustainability activities
- The environment.
- Establishing partnerships with community parties concerned with environmental sustainability and sharing the results (e.g., United Nations - UNESCO - Ministry of Environment)
- Implementing environmental sustainability initiatives to serve the community (e.g., afforestation initiatives - environmental awareness - and waste recycling)

Measurement indicators

- The support provided to innovative projects that serve sustainable environmental development
- The number of active partnerships with relevant community institutions.
- The interaction of the various parties with the sustainable environmental development initiatives of the university, and the extent of taking advantage of technological development
- The number of environmental sustainability initiatives
- Questionnaires

3. The governance system and administration system serve sustainability

The Environmental Sustainability Committee at Assiut University is formed and approved under the chairmanship of Prof. Dr. Vice President for Environmental Affairs and Community Service, and with the membership of several faculty members, their assistants, and several students. At the same time, they ensure that they represent the various faculties on campus. This committee is responsible for developing, implementing, and following up on the university's environmental sustainability plan.

- Develop and implement an Environmental Management System (EMS) that complies with ISO 14001 to ensure commitment to continuous improvement of the Environmental Management System to enhance environmental performance
- Inventory and document all university activities aimed at achieving environmental sustainability
- Supervising, promoting, and monitoring the implementation of the environmental sustainability plan
- Supervising the progress of the strategic plan and submitting periodic reports on its activity about environmental achievements at the level of all faculties at the university, areas of improvement, and any related issues
- Measuring the sustainability performance at the university periodically
- Provide information on sustainability-related activities at the university

4. Maximizing environmental sustainability practices

This goal focuses on maximizing environmental sustainability practices within the university and its various operations with the importance of the university's belief as a leading educational institution in achieving environmental sustainability and starting to activate these practices in its various facilities that serve society.

Activities and implementation mechanisms

- The university's commitment to preventing pollution and reducing its negative impact on the environment
- Reviewing environmental sustainability activities to comply with all relevant local and international legislative and regulatory requirements
- Consider using renewable energy to reduce one's reliance on electricity
- The installation of water conservation and consumption devices and technology resulted in a 15% reduction in water consumption
- Reduce trash and hazardous waste disposal practices, and promote recycling on the university campus and buildings
- Promoting environmentally friendly transportation within the university and applying this to the operation of university-owned vehicles

- Promoting green procurement practices in all university procurement processes, as well as assisting suppliers with whom the university works to improve their environmental performance
- Environmentally friendly maintenance of campus and university buildings
- Reduce the use of pesticides in garden care
- Activating a health transaction mechanism for food and beverages on university campuses.
- Keeping and upgrading the campus's aesthetic appearance.
- Maximizing the environmental value of steps taken to deal with the Corona pandemic and preparing for outbreaks.

Measurement indicators

- Pollution decrease indicators
- Ratios of decreasing energy consumption
- Reports on waste recycling
- The university reports on lowering carbon emissions from vehicles.
- The approval of the green procurement document and associated reports
- Reports on campus and garden maintenance
- Health reports for foods and beverages.
- Questionnaires.

Time Range

Three years from 2021 to 2024

5. Enabling undergraduate and postgraduate education to play a larger role in attaining environmental sustainability

This goal emphasizes the importance of undergraduate and graduate education in achieving environmental sustainability.

The importance and role of science in achieving this, whether in terms of raising awareness of the importance of improving environmental performance or in terms of providing solutions to environmental problems, is by adopting the scientific and innovative method.

Activities and implementation mechanisms

- Presenting concepts of sustainable environmental development as part of the core curriculum for all disciplines
- Providing environmental sustainability training programs for diverse segments of society
- Supporting scientific study on concerns of sustainable environmental development
- Encourage research that promotes new ideas, beliefs, and practices in environmental sustainability and citizenship

- Encourage the creation, testing, and adoption of novel ideas and technology that promote environmental sustainability and address or resolve environmental challenges

Measurement indicators

- The number of faculties that include environmental sustainability themes in their curricula.
- The number of environmental sustainability training programs offered to community members.
- The quantity of scientific study on environmental sustainability that has been submitted.
- The amount of funding granted for scientific study and innovative projects aimed at resolving environmental problems.

6. Establishing the Assiut University Center for Sustainable Development

In light of the increased international interest in sustainable development issues in recent years, there has been increased interest in the concept of sustainability in education, intending to develop a generation capable of dealing with sustainable development. One of the goals of sustainable development is to focus on the lives of future generations and create a society capable of understanding and working to safeguard our natural resources.

To attain the desired sustainable development, education and the various challenges and problems related to it have become crucial and worthy of inquiry.

Higher education institutions have paid special attention to the fact that they have many tasks in today's world, they must reduce their environmental impacts resulting from the various direct and indirect activities that take place in educational institutions, conduct research, and provide education in the field of sustainability. It also prepares an environment that allows students and workers to develop new capabilities that lead to sustainable practices, resulting in a more sustainable society.

"Egypt Vision 2030" sustainable development strategy has accepted the concept of sustainable development as a broad framework to increase the quality of life now without compromising future generations' rights to a better living.

Among the most important axes on which the strategy is based is the axis of an integrated and sustainable environmental system to confront the impact of climate change, enhance the resilience of ecosystems, enhance flexibility, and have the ability to confront natural risks and disasters. The strategy also seeks to increase reliance on renewable energy, preserve nature, and protect its resources and biodiversity. It strives to adopt sustainable consumption and production patterns, achieve the best use of

natural resources, govern state and societal institutions, conduct administrative reform, and improve the efficiency and effectiveness of government agencies. Also, it seeks to consolidate transparency and fight corruption, support monitoring, follow-up, and evaluation systems, and make data available, in addition to strengthening partnerships between all development partners, enhancing accountability and the rule of law, and empowering local administration.

In this context, Assiut University established the Center for Sustainable Development in 2022 to work on achieving the 17 United Nations Sustainable Development Goals and to work on improving Assiut University's ranking in the international university classification (THE) for achieving sustainable development goals.

The vision and mission of the Center for Sustainable Development at Assiut University

- **Vision**

Creating, implementing, and pursuing procedures to sustain Assiut University's excellence in sustainable development and ensure its presence at the pioneering ranks of Egyptian, Arab, and international universities.

- **Mission**

- Contributing effectively to the implementation of the science, technology, and innovation strategy 2030 to fulfill the seventeen United Nations Sustainable Development Goals (SDGs) and the strategic objectives of Egypt's future vision.
- Promote the notion of institutional sustainability and seek to build new educational programs to educate and graduate future leaders with the skills needed to confront diverse problems in the areas of sustainable development.
- Improving and expanding the university's resources through sustainable management, as well as designing, implementing, and monitoring sustainable practices on campus.
- Strengthening university research programs on sustainable development in areas such as poverty, renewable energy, and conflict resolution, in addition to the other seventeen United Nations Sustainable Development Goals (SDGs) and accordance with Egypt's strategic objectives for the future.

The University's Center for Sustainable Development's operational goals

- Create processes, plans, and programs to manage and monitor work on campus to rationalize energy and water consumption using sustainable techniques.
- Follow-up, implementation, and oversight of hazardous waste management initiatives in the medical sector on campus and in university hospitals in a sustainable manner.
- Monitor the implementation of Assiut University's visual identity to ensure that it is consistent with the philosophy of sustainable development.
- Project preparation, follow-up, and supervision of the university's development of sustainable development awareness.

- Help to prepare the university's file for international rankings in the field of sustainable development.
- Developing human cadres capable of generating innovative, sustainable, ecologically compatible, socially just, and economically viable solutions to the university's and the surrounding community's problems.
- Submitting project proposals to local and international financial authorities to finance the implementation of sustainable development projects, as well as signing agreements and protocols of collaboration with international institutions working in all areas of sustainable development.
- Improve carbon footprint tendencies and continue to reduce emissions on and off campus.
- Inclusion of the concept of sustainable development in Assiut institution's programs and areas of scientific study, as well as the use of research outputs and patents to develop and serve the institution in the field of sustainable development.
- Establishing and supervising the creation of companies by Law No. (23) of 2018 for Science, Technology, and Innovation Incentives to serve the university, the university community, and the surrounding community.
- Providing training, and educational services to the university community and the surrounding community in areas related to achieving sustainable development goals, by the approved rules governing this.
- Establishing strategic relationships for collaboration among universities, corporate organizations, social society, and different scientific and non-scientific groups both at home and abroad to achieve long-term development goals.
- Monitoring the formation of new offices at the university's faculties and institutes to coordinate activities related to the institution's sustainable development goals among the various university administrations.

- Making informative short videos about environmental sustainability
- Appoint university sustainability ambassadors who will form teams to perform visits to community institutions to extend the university's role in environmental sustainability
- Holding student competitions to encourage involvement in environmental sustainability initiatives
- Establishing the Student Forum for Environmental Sustainability at Assiut University

1.5 Community services provided by the Foundation that support sustainability

Today, it is widely accepted that universities must perform three essential functions: education, scientific research, and community service. These are fundamental and interrelated tasks that operate together to achieve various goals, beginning with knowledge dissemination, behavior modification, and skill acquisition.

(Education) as well as the development of knowledge and its findings and development (scientific research), and finally the application of knowledge in solving societal problems and servicing its members to achieve societal well-being.

University institutions have become playing an important and decisive role in revealing the problems of society and providing practical solutions capable of addressing these problems, and universities have turned into pillars on which societies rely to achieve development and prosperity at various levels.

The connection between universities as knowledge institutions and society has pushed them beyond their traditional teaching roles. This role has expanded to be centers for research, planning for the future, and community service. Its role in the development of society and building its capabilities has become an indisputable issue.

It has become widely established that universities have a crucial role in achieving development in all its social, economic, political, cultural, environmental, and other aspects that constitute the macro aspects, which have become known as sustainable development. It is a concept developed by the United Nations organizations since the nineties of the twentieth century and stressed that achieving this development sustainability through the participation of all institutions of society, including the university institution.

In light of the concept of social responsibility, universities' roles are no longer exclusively focused on achieving internal efficiency. As a result, the overarching purpose of university social responsibility is to contribute to attaining sustainable development that leads to poverty eradication, societal fairness, and addressing societal demands utilizing available resources.

It is considered that universities give social responsibility services and activities. Because there is a close link between the university's social responsibility applications and boosting its competitiveness, it will help to build its institutional capacity and strengthen its strength in achieving excellence.

From this perspective, this goal focuses on strengthening the university's services in a sustainable manner based on the principle of social responsibility, by increasing efforts directed towards the community (internally and externally) for its development in the following areas:

- Environmentally oriented activities and services (externally)
- Social and developmental activities and services (externally)
- Human resource-related activities and services (internally)
- Beneficial activities and services (both internally and externally)
- Activities and services geared toward students (internally and externally)

- Changing the term "social responsibility" to "social response," which includes the existence of a motivation or incentive for institutions to bear social responsibility.
- Motivating the state to facilitate procedures linked to universities' social responsibility performance, as well as providing structural incentives for universities based on their excellence in social responsibility.
- Requesting the concerned authorities to provide the necessary infrastructure for universities to carry out their social responsibility, in particular systems and the provision of studies and information in light of the actual needs of society.
- Strengthening universities' effective role in serving society, contributes to the development of a healthy social fabric capable of promoting individuals and the country, as evidenced in university performance. The presence of universities in conscious, civilized, and developing societies helps to the existence of universities capable of competing on a worldwide scale.
- Overcoming the problems and challenges that contribute to the university's inability to carry out its social responsibilities effectively and continuously.
- Contribute to the development of a social responsibility and community service strategy capable of organizing efforts and activating mechanisms to achieve the objective of community service sustainable. It is not only the formation of

courses, programs, and projects but also the trend toward institutional activity based on a clear strategy, which integrates social responsibility in the purpose of each university and as one of its work objectives.

- A need for specialized social responsibility departments within universities to plan and implement programs and coordinate with relevant authorities, provided that they report directly to senior management, exchange expertise, and practical experiences among one another, and identify strengths and weaknesses to apply the best possible methods in the areas of social responsibility.
- Contribute to the creation of a national index for social responsibility in Egyptian universities to assess the degree of their efforts in implementing social responsibility, provide sufficient assessments, and compare them.

University activities in dealing with climate issues: Action taken

- Awareness symposium held under the title “Climate Change and its Impact on the Environment”.



The symposium concluded with some recommendations that can be summarized as follows:

1. Although climate change is challenging, one should learn more about its consequences by holding more events, particularly on climate engineering practices.
2. Coordination for obtaining donation funding opportunities for developing countries most affected by climate change, including Egypt.
3. Coordinating to obtain scholarships for students and postgraduates in the field of climate change, especially in areas where chemtrails are released.
4. Develop new crops that have a short growing season, tolerate severe heat, salinity, and drought, and are compatible with climate change.
5. Change planting dates to suit the climate change conditions, as well as planting appropriate varieties in the appropriate climate zones to increase the crop yield per unit of water for each crop.
6. Commitment to the area of water-intensive crops, i.e., rice and sugarcane.
7. Planting alternative crops that serve the same purpose and have a water consumption and a shorter growing season, i.e., sugar beets instead of sugar cane. It is noteworthy that this crop is a major crop in Upper Egypt, and the factories, secondary industries, and employment depend on it.
8. Focus on wastewater treatment and utilizing it to irrigate some plants, as well as desalinate seawater, preserve rainwater and wells, as well as employ modern irrigation systems to preserve every drop of water, which humans will badly need under climate change conditions.
9. Paying attention to agricultural waste recycling and composting, Reducing waste burning.

10. The necessity of concluding a cooperation protocol between Assiut University and Building Resilient Food Security Systems to Benefit the Southern Egypt Region project, The project intends to develop a mechanism for adapting to climate change in diverse agricultural production sectors while also reducing carbon dioxide emissions. It carried out a series of actions in twenty villages spread over the governorates of Assiut, Sohag, Qena, Luxor, and Aswan over the preceding years to present a set of integrated solutions for climate change to adapt to the negative impact of weather fluctuations.

Preface

Having faith in the role of Egyptian universities with all their faculties, institutes and research centers in participating in community service and environmental development by contributing to national issues, especially the issue of illiteracy because of the real dangers it represents to the growth and development of Egyptian society, Assiut University, represented by its concerned faculties, signed a cooperation protocol with the General Authority for Adult Education to start implementing a pioneering experiment in Assiut Governorate based on four main axes:

- The efforts of human cadres in the concerned faculties to eradicate illiteracy for several illiterates in the villages, neighborhoods and centers of the governorate, including faculty members and students, provided that the student shall eradicate illiteracy of (8) illiterates during the student's academic period.
- Eradicate illiteracy for all university employees and declare it free from illiteracy.

- Conducting field surveys and counting illiterate people in Assiut Governorate, while considering the Authority for Adult Education branch at Assiut Governorate as a research area by the university.
- Participating in the development of technical capabilities of employees of the Authority for Adult Education branch at Assiut Governorate in the educational process, and due to the two parties' desire to cooperate with the capabilities they have that may achieve the agreed-upon axes, both parties agreed that this preamble is considered a part and parcel of the joint cooperation framework.

Article (1)

To achieve the desired objectives, the two parties are committed to establishing a general policy and determining their method of work in this agreement in complete agreement and cooperation. The two parties may make the necessary modifications for the benefit of the project in accordance with an appendix attached to this protocol and considered an integral part of it. The Second Party is bound by the First Party's instructions governing the educational process and the financial exchange procedures.

Article (2)

Obligations of the Parties to the Protocol (aspects of cooperation):

First: The General Authority for Adult Education (The First Party):

- Providing the educational process's necessities (guides - Authority-approved sources of knowledge - pens - notebooks),
- Before contracting, approve and review the "full data" lists of students registered in the classes submitted by the second party,

- Conduct technical and administrative follow-up work for classes in coordination between the two parties in accordance with the following procedures:
 1. Follow-up through administrative centers and branches
 2. Follow-up through the head office
 3. Joint committees from the two parties
- Preparing a quarterly report to measure the extent of project implementation, seriousness of work, and results achieved in each examination cycle, where the Protocols Unit in the branch prepares it and sends one copy to the follow-up office of the head office (the general office) and the other copy to the university.
- facilitating the work of the faculties carrying out the project in the target governorate in accordance with the organizing body's directives, as well as providing the technical support required for the project's implementation, supervision, follow-up, and evaluation of what is being implemented.
- The number of successful students must be disclosed to the teachers (student) on the Authority's website at Assiut Governorate.
- Evaluating the protocol's work throughout the year by the Planning Department of the General Office to determine its strengths and weaknesses. The evaluation is based on quarterly reports submitted by:
 - The authority's branch in the governorate, scope of implementation. It will be delivered to the Planning Department or the Follow-up Office of the Head of the Service at the General Office.

2. Reports of protocol coordinators from both parties.
3. Follow-up and guidance management at the General Office.
 - Participate in the preparation of a media and advertising component to market and launch the project, as well as display some successful project models, in collaboration with the second party.

Second: Adult education obligations and responsibilities at the Faculty of Education (The Second Party):

The Adult Education Center at the Faculty of Education shall implement the project through its specialized human cadres at the university, project participants, and specialists in teaching adult education and its applications (including faculty members and students) to eliminate illiteracy among university workers, villages, neighborhoods, and governorate centers.

- Preparing lists of names of candidates to work as teachers in literacy programs, as well as supplying detailed data to the First Party, including contractual terms.
- Preparing lists of students in the age group (16 and up) with complete information (name, gender, age, educational status, place of residence, copy of national ID card) in accordance with the form prepared for this and issued by the Authority immediately after contracting to register them on the students' database.
- Commitment to the student lists provided at the commencement of the contract in the freelance system. Any changes to these lists after verifying the class lists shall not be considered.

- Participating with the First Party in conducting a follow-up to the classes to determine the seriousness of work on the project classes, and provide what is necessary to conduct the follow-up with a commitment to implementing the recommendations of the follow-up report,
- It is the responsibility of the Adult Education Center at the university to notify the Authority with a hard copy of the student's receipt of their financial dues based on their results announced on the Authority's website in Assiut branch, no later than one month from the announcement of the result,
- Awarding student who participated in the success of his learners a certificate of appreciation,
- The Adult Education Center at the Faculty of Education, in cooperation with the branch of the General Authority for Adult Education in Assiut Governorate, prepares and qualifies (trains) university youth participating in the project on the methods and techniques of adult education through its specialized departments,
- The Faculty of Education's Adult Education Center offers training programs to improve the effectiveness of employees working in the Assiut Governorate's literacy sector. These programs focus on management skills, financial matters related to adult education, and effective adult communication techniques as well as the matters related to advertising and media.

Administrative and institutional aspects:

- Preparing a quarterly report on the results of each examination session, outlining the benefits and drawbacks of the executive measures, showing the obstacles that prohibit the fulfillment of the agreed-upon goal, and providing a proposal to overcome those difficulties. The report shall be attached to the examination session results and three copies thereof shall be provided (one copy to the Protocols Unit in the General Office, the second to the branch under the implementation scope, and the third copy to the partner party).
- Making the required recommendations to ensure the project's success and continuance.

Article (6)

This protocol is valid for one year from the date of signing if it is renewed annually based on the annual achievement report generated by the Protocols Unit to assess the seriousness of the work and the rate of attaining 60% of the target. If any party decides not to extend the protocol for another period, it must tell the other party in writing of his desire to terminate the agreement within two months of the agreement's expiration date.

Article (7)

Any dispute arising from the execution or interpretation of any provision of this Protocol shall be addressed by a committee chaired by both parties, and recourse to the judiciary shall be avoided unless all conciliatory measures have been exhausted.

The university's social and humanitarian role in serving and supporting incapable groups and those experiencing social difficulties must be emphasized. It should also be noted that the university administration is eager to take on this responsibility and contribute to creating a decent life for the most vulnerable groups both inside and outside the university, in collaboration with associations and civil society organizations.

Similarly, Dr. Hassan Salah, former Vice President of Assiut University and Chairman of the Board of Directors of the Upper Egypt Patients Rescue Association, revealed that the university continues to work with the association on the annual charitable campaign, which aims to distribute Ramadan bags to individuals. This year, it included the delivery of 1,100 bags, which were donated by benefactors, including university staff members and association friends, to help the most vulnerable individuals. The bags contained the most critical fundamental commodities that contribute to the Egyptian family's basic needs.

Dr. Thabet Abdel Moneim, Director of the Center for Environmental Studies and Research and Vice Chairman of the Association's Board of Directors, revealed that Ramadan bags were delivered today to university needy employees. Outside of the university, the Association visited several streets, squares, and some of Assiut's most impoverished neighborhoods. He stated that the bag contained the most important food commodities, such as "sugar, tea, ghee, rice, and pasta," and that the association continues to receive direct donations at the association's headquarters in the community service sector in the university's administrative building, as well as on bank account number 364/1/3000 in Egypt, Assiut University Branch.

- On Thursday, 17 December 2020, Assiut University opened the first center in Upper Egypt to care for students with special needs. It includes a training hall, a center for printing books in Braille, a cultural library, devices, and halls equipped with computers for the visually impaired, and training halls.
