Education system:

Article no. (79) of executive regulation of universities organization rule states that education system is going to be one Academic year. Education might be based on stages system or two terms or any other system according to internal regulations of faculties.

Education system in Assiut University is two terms system, starting from the academic year 1993\1994, except faculty of Medicine that is following one Academic year.

Exams system:

Article no. (82) Of executive regulation states that transition between levels will not be done, only by the end of the academic year. Student will not repeat the exam in the course he\she passed.

Formation of exam committees:

According to article no. (82) of executive regulation of universities organization rule, stating that exams committer of senior year, each course will be formed of triple committee. This is according to a resolution from president of supreme council of universities, according to a proposal from the authority of each committee office for each sector in university education sector.

For pre-senior year, a committee is formed of two members chosen by faculty council based on request from council of student affairs, according to article no. (71) Of executive regulation that was previously mentioned.

Complementary exams:

Student who gained a foreign secondary certificate, does not undergo Arabic and Religion in presence of Egyptian secondary exam committee. Student has to undergo a complementary exam during education period at the faculty. Student will not earn license and bachelor degrees only after passing previously mentioned courses exam.

Depriving student from part of whole exam:

According to Article no. (69) From executive regulation of faculty council and according to request of departments' councils and according to rules of internal regulation, Student will be

deprived from the part or whole exam in case of un- accepted diligence. In this case student will be considered failed in deprived courses.

Rules of accepting medical excuses:

The last paragraph of Article no. (80) of the executive regulations of the Universities Organization Law states that:

"If the student fails to enter the exam with a compelling excuse accepted by the faculty council, his absence will not be considered a failure, provided that the failure does not exceed two consecutive or separate opportunities during the years of study in the faculty and in case of necessity a decision by the University Council may give the student a third chance."

We can conclude from the previous text, the following facts:

- 1 The number of failures (years), the student's absence from taking the exam with an acceptable excuse, is not counted from the chances of failing that he is allowed not to pass them by his group.
- 2 The maximum number of times students accepting their apologies for exams has become absolute and unlimited.
- 3 The competent authorities vested with the authority to make decisions accepting students' excuses for taking the exam are the college boards only
- And in implementation of the foregoing, the University Council approved, in its session held on 5/27/2007 AD, the rules of sick excuses that students submit to excuse themselves from studying and examinations in the faculties of the university.

Available chances to take exam:

Article no. (80) States that student must not be in the year for more than two years. Faculty council is in charge of allowing students who have been for two years to apply for exam externally in the following year in failed courses. This is not allowed for primary and first year student in faculties that don't have primary years.

Faculty council may give another two chance in addition to the previously given ones.

As for the five years faculties, second and third year students in faculties that have and don't have primary years, are considered as pre-senior students. In case if the student failed in this level in more than half of courses disregarding previously failed courses, has the chance to take the exam till success.

If the student didn't take the exam with a compelling excuse accepted by faculty council, student is not considered failure. Student who did not take the exam with un-accepted excuse is considered failed with grade (very poor).

Calculating General grade:

Student general grade is calculated for each level according to grades students earn, taking in consideration student's grade should not exceed (Accepted) per each course, that student previously failed in it or did not take the exam with an accepted excuse. In case if the student did not take the exam with an accepted excuse, success grade is according to previously earned grade.

Grades are divided to: (Excellent- Very Good- Good- Accepted).

In case of failure, grades are: (Poor- Very.Poor).

Grades of previous years are calculated according to internal regulations of the faculty.

In case if the exam is divided into oral and written, the student who is absent in the written exam, is considered absent in the course and does not list any grades for this student.

Grades calculation in both license and bachelor degrees:

Article no. (85) From edited regulation with presidential resolution no. (37 for year 1989), grades are according to the following:

(Excellent- V.Good- Good- Accepted)

The general grade of students in the license or bachelor's degree is calculated on the basis of the total number of degrees obtained in all academic years, and they are arranged according to this total.
